Bids will be publicly opened and read at the Clinton County Sanitary Landfill at the time and date as stated above.

A mandatory pre-bid meeting will be held on Monday, July 29, 2024, at 9:00 a.m., local time, at the Clinton County Sanitary Landfill located at 4292 220th Street, Clinton, IA 52732. Representatives of the Owner will be present to discuss the project. Bidders are required to attend and participate in the conference. Engineer will transmit to all plan holders such addenda as Engineer considers necessary in response to questions arising at the conference. Oral statements may not be relied upon and will not be binding or legally effective.

Each proposal shall be accompanied by a Bid Bond or certified check equivalent to **10%** of the amount of the maximum bid amount for one year of the contract, payable to the order of the Agency, as security that the successful bidder will enter into a contract for the work bid upon and will furnish after the award of contract a corporate surety bond, acceptable to the governing body, for the faithful performance of the contract. This sum shall be forfeited in case the bidder fails to enter into the contract within twelve days after the Notice of Award has been issued. No Bidder may withdraw their Bid after the time for opening bids has passed.

The Owner reserves the right to reject any or all Bids, waive or not waive any informalities in the Bids received and to accept any proposal which is deemed most favorable to the interests of the Owner. Bids received after the posted time will not be opened. Some delivery services may not make the due time. Bidders are responsible for any delays or fault of the delivery service used.
